

## **JUNE 10, 2019**

The Greene City Council met in regular session at 5:00 p.m. on Monday, June 10, 2019 at the Greene Community Center with Mayor William Christensen presiding. Council members present were Al Zweck, Denise Shreve, Marnie Schmidt and Marilyn Folkers. Ben Backer was absent. Also present were Marietta McCormick, Andrea Gotto, Rustin Lingbeek, Mike Danburg, Dave Warner, Tim Joebgen, Ed Corwin, Cory Wiegmann and Bev Schuknecht.

Motion by Zweck/Folkers to approve the agenda. Roll call, all ayes. MC

Motion by Folkers/Schmidt to approve the May 22<sup>nd</sup> minutes. AYES: Folkers, Schmidt and Zweck. Shreve abstained as she was not at that meeting. MC

Rustin Lingbeek from SEH spoke with Council about the progress at the lagoon. Sand and dirt work are being done along with work on the building. The third cell has been emptied and is being relined. Motion by Zweck/Schmidt to approve payment request #5 for \$491,514.80. Roll call, all ayes. MC

Mike Danburg from SEH briefly went over plans and time schedule for the 2020 North First Street Project. Motion by Schmidt/Shreve to approve an Agreement for Professional Services Between the City of Greene and Short Elliot Hendrickson, Inc. not to exceed \$78,900. Roll call, all ayes. MC

Zweck introduced Resolution 2019-06, A RESOLUTION AUTHORIZING THE CITY CLERK TO TRANSFER FUNDS FROM THE LOCAL OPTION SALES TAX FUND TO THE DEBT SERVICE FUND TO BE USED FOR EMERGENCY SERVICES BUILDING LEASE PAYMENT and moved for its adoption. Seconded by Schmidt. Roll call AYES: Zweck, Schmidt, Folkers and Shreve. NAYS: None. ABSENT: Backer. MC

Folkers introduced Resolution 2019-07, A RESOLUTION AUTHORIZING THE CITY CLERK TO TRANSFER FUNDS FROM THE COMMUNITY CENTER MONEY MARKET TO THE GENERAL FUND FOR THE ADDITION OF SPRINKER SYSTEM TO THE STORAGE ROOM and moved for its adoption. Seconded by Schmidt. Roll call AYES: Schmidt, Folkers, Shreve and Zweck. NAYS: None. ABSENT: Backer. MC

Folkers introduced Resolution 2019-08, A RESOLUTION SETTING SALARIES/WAGES FOR APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF GREENE, IOWA FOR JULY 1, 2019 THROUGH JUNE 30, 2020 FISCAL YEAR and moved for its adoption. Seconded by Zweck. Roll call AYES: Shreve, Folkers and Zweck. NAYS: None. ABSENT: Backer. Schmidt abstained due to being an employee of the Library. MC

Schmidt introduced Resolution 2019-09, A RESOLUTION AUTHORIZING THE CITY CLERK TO TRANSFER FUNDS FROM THE EMERGENCY FUND TO THE GENERAL FUND and moved for its

adoption. Seconded by Zweck. Roll call AYES: Folkers, Shreve, Schmidt and Zweck. NAYS: None. ABSENT: Backer. MC

Zweck introduced Resolution 2019-10, A RESOLUTION NAMING DEPOSITORIES OF PUBLIC FUNDS and moved for its adoption. Seconded by Folkers. Roll call AYES: Schmidt, Shreve, Zweck and Folkers. NAYS: None. ABSENT: Backer.

Schmidt introduced Resolution 2019-11, A RESOLUTION AUTHORIZING THE CITY CLERK TO TRANSFER FUNDS FROM THE SPECIAL ASSESSMENT FUND TO THE GENERAL FUND and moved for its adoption. Seconded by Shreve. Roll call AYES: Zweck, Folkers, Schmidt and Shreve. NAYS: None. ABSENT: Backer. MC

Folkers introduced Resolution 2019-12, A RESOLUTION AUTHORIZING THE CITY CLERK TO TRANSFER FUNDS FROM THE SPECIAL ASSESSMENT FUND TO THE CAPITAL IMPROVEMENTS STREET FUND and moved for its adoption. Seconded by Schmidt. Roll call AYES: Shreve, Zweck, Schmidt and Folkers. NAYS: None. ABSENT: Backer. MC

WHEREUPON the Mayor declared Resolutions 2019-06 thru 2019-12 duly adopted. (Mayor's signature affixed and made a permanent part of these minutes.)

Motion by Folkers/Zweck to approve cigarette permits for Casey's General Store and Dollar General. Roll call, all ayes. MC

Andrea Gotto gave a brief pool update. Tile work has been completed and pool is anticipated to be open on Thursday June 13th

Nuisance issues were briefly discussed.

Motion by Folkers/Schmidt to approve the claims. Roll call, all ayes. MC
