The Greene City Council met in regular session on Monday, January 11, 2021 at 5:00 p.m. via both Zoom and regular attendance with Mayor William Christensen presiding. Council members attending via Zoom were Al Zweck and Rod Fesenmeyer. Other Council members also attending the meeting were Marnie Schmidt, Marilyn Folkers and Ed Corwin. Guests attending were Cory Wiegmann, Andrea Gotto, Bev Schuknecht and Brooke Schroeder.

Motion by Schmidt/Zweck to approve the agenda. Roll call, all ayes. MC

Motion by Folkers/Corwin to approve the December 14th minutes. Roll call, all ayes. MC

Fesenmeyer arrived at 5:05 p.m.

Brooke Schroeder updated the Council regarding upcoming pool activities. The Board is beginning the hiring of guards and managers for the 2021 season. They are looking into the possibility of using the "Square" for timecards and concession sales/inventory along with possibly getting security cameras and WI-FI. Motion by Folkers/Schmidt to approve wages for 1st year guards at \$8.75 and returning guards will be \$9.00. Roll call, all ayes. MC

The elementary school housing project was briefly discussed. A probable cost of engineering and a preliminary overall development plan from Veenstra & Kimm was reviewed.

Motion by Corwin/Schmidt for the purchase a new City pickup from the 2020-2021 budget with a maximum of \$40,500. Roll was called and the vote was Ayes: Schmidt, Corwin, Fesenmeyer and Zweck. Nays: Folkers. MC

Mayor Christensen declared that this was the time and place for a public hearing to apply for a reimbursement for the Parish Public Food Bank from the IEDA CDBG COVID-19 Grant. There were no oral or written comments. The hearing was closed. Motion by Schmidt/Folkers to apply for the reimbursement. Roll call, all ayes. MC

Motion by Schmidt/Zweck to approve a Class B Wine Permit, Class C Beer Permit and Class E Liquor Permit for Casey's Marketing. Roll call, all ayes. MC

Motion by Folkers/Fesenmeyer to hire Servpro to clean & deodorize the community center/city hall bathrooms. Roll call, all ayes. MC

Motion by Schmidt/Corwin to appoint Cory Wiegmann as the new Fire Chief effective 1-11-21. Roll call all ayes. MC

Mayor Christensen would like to thank Neal Nordmeyer for his years of service as the Fire Chief.

Motion by Folkers/Corwin to approve the claims. Roll call, all ayes. MC
