

## **MAY 24, 2021**

The Greene City Council met in special session on Monday, May 24, 2021 at 4:30 p.m. at the Greene Community Center with Mayor William Christensen presiding. Council members present were Marnie Schmidt, Marilyn Folkers, Al Zweck and Ed Corwin. Rod Fesenmeyer was absent. Cory Wiegmann was also present. Heather Prendergast participated via Zoom

Motion by Schmidt/Corwin to approve the agenda. Roll call, all ayes. MC

Motion by Zweck/Folkers to approve the May 10<sup>th</sup> minutes with the correction of Rose Philips oral comments. Under paragraph 2 of the Nature and Location of Proposed Activities, "Blackhawk County" was corrected to read "Butler County". The May 18<sup>th</sup> minutes were approved also. Roll call, all ayes. MC

Schmidt introduced Ordinance No. 100 – AN ORDINANCE AMENDING AND SUPPLEMENTING ORDINANCE 197 DATED OCTOBER 3, 1967 AS FOLLOWS: THE CITY PREVIOUSLY VACATED THE ALLEY EXTENDING SOUTHEASTERLY FROM DOW STREET LOCATED IN BETWEEN MAIN STREET AND WATER STREET. THE CITY HEREBY SUPPLEMENTS THE PREVIOUS ORDINANCE TO INDICATE THAT THE VACATION OF ALL RESULTED IN THE FOLLOWING DESCRIBED PROPERTIES ACQUIRING OWNERSHIP OF THE ALLEY AS FOLLOWS: (A COMPLETE COPY OF THE ORDINANCE No. 100 IS ATTACHED AND PUBLISHED) seconded by Folkers. Roll was called and the vote was AYES: Schmidt, Folkers, Corwin and Zweck. ABSENT – Fesenmeyer. MC

Motion by Schmidt to approve Ordinance No. 101 – AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GREENE, IOWA BY AMENDING CHAPTER 92 – 92.10 TEMPORARY VACANCY. (A complete copy of Ordinance No. 101 it attached and published) seconded by Folkers. Roll was called and the vote was AYES: Schmidt, Folkers, Zweck and Corwin. Fesenmeyer was absent. MC

Motion by Schmidt/Corwin to waive the second and third readings of Ordinance No. 101. Roll call, all ayes. MC

Motion by Schmidt to approve Ordinance No. 102 - AN ORDINANCE AMENDING CHAPTER 50.02 OF THE CODE OF ORDINANCES OF THE CITY OF GREENE, IOWA. 50.02(9) Nuisances Enumerated. 9. Weeds, Brush. Roll was called and the vote was AYES: Corwin, Folkers, Zweck and Schmidt. Fesenmeyer was absent. MC

Motion by Folkers/Schmidt to waive the 2<sup>nd</sup> and 3<sup>rd</sup> readings of Ordinance No. 102. Roll call, all ayes. MC

Motion by Folkers/Zweck to approve a Cigarette/Tobacco/Nicotine/Vapor permit for Dollar General Store #18421. Roll call, all ayes. MC

Motion by Zweck/Schmidt to adjourn at 5:16.
