

**JUNE 29, 2020**

The Greene City Council met in special session on Monday, June 29, 2020 via both Zoom and regular attendance with Mayor William Christensen presiding. Council members participating via Zoom were Marnie Schmidt, Ed Corwin and Rod Fesenmeyer. Al Zweck and Cory Wiegmann attended the meeting. Maggie Burger participated via Zoom also.

Motion by Schmidt/Zweck to approve the agenda. Roll call, all ayes. MC

Motion by Zweck/Fesenmeyer to approve the June 8, 2020 minutes. Roll call, all ayes. MC

Maggie Burger, Speer Financial, discussed with the City Council the bond sale that was held earlier in the day for the North First/Harrison/Butler street projects.

Schmidt introduced RESOLUTION 2020-30, A RESOLUTION AWARDDING GENERAL OBLIGATION CORPORATE PURPOSE BONDS, SERIES 2020 and moved for its adoption. Seconded by Corwin. Roll was called and the vote was AYES: Schmidt, Corwin, Fesenmeyer and Zweck. NAYS: None. ABSENT: Folkers. MC. UMB Bank out of Kansas City, MO won the sale with a 1.5156% interest rate.

Schmidt introduced RESOLUTION 2020-29, A RESOLUTION ESTABLISHING AND DESIGNATING LOCATIONS FOR CERTAIN TRAFFIC CONTROL DEVICES IN THE CITY OF GREENE, IOWA (NO PARKING SIGNS ON THE SOUTHWEST SIDE OF WEST ELY STREET AND ON BOTH SIDES OF NORTH WATER PLACE STREET) and moved for its adoption. Seconded by Corwin. Roll was called and the vote was AYES: Schmidt, Corwin, Zweck and Fesenmeyer. NAYS: None. ABSENT: Folkers. MC

Corwin introduced RESOLUTION 2020-31, A RESOLUTION APPROVING CONTRACT AND PERFORMANCE AND/OR PAYMENT BONDS FOR THE NORTH FIRST STREET IMPROVEMENT PROJECT and moved for its adoption. Seconded by Fesenmeyer. Roll was called and the vote was AYES: Zweck, Schmidt, Corwin and Fesenmeyer. NAYS: None. ABSENT: Folkers. MC
